

WAIVER OF LIABILITY RELATING TO CORONAVIRUS/COVID-19

The novel Coronavirus has been declared a worldwide pandemic by the World Health Organization and according to the U.S. Centers for Disease Control and Prevention, COVID-19, the disease caused by Coronavirus, is contagious. COVID-19 can cause serious and potentially life threatening illness or death. Sonoma Media Investments, LLC is following published guidance and directives (collectively, "Directives") from federal, state and local governmental agencies regarding the COVID-19 pandemic. I am aware that I could be infected, seriously injured or even die due to COVID-19 or due to my participation in the Activities. I am voluntarily participating in the Activities with knowledge of the danger involved including potential exposure to COVID-19, and agree to assume any and all risks of bodily injury, death or property damage, whether those risks are known or unknown.

As consideration for being permitted by Sonoma Media Investments, LLC to voluntarily participate in the Activities, I forever release the Sonoma Media Investments, LLC, and any of its affiliated companies, along with their respective directors, officers, employees, volunteers, agents, contractors, and representatives (collectively "Releasees") from any and all liabilities, causes of action, lawsuits, claims, demands, or damages of any kind whatsoever that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives now have, or may have in the future, for injury, death, or property damage, related to (i) my participation in the Activities, (ii) the negligence or other acts of any Releasee, whether directly connected to the Activities or not, and however caused, or (iii) the condition of the premises where the events occur. I also agree that I, my assignees, heirs, distributees, guardians, next of kin, spouse and legal representatives will not make a claim against, sue, or attach the property of any Releasee in connection with any matters covered by this release.

I have carefully read and understood the above warnings about COVID-19. With full awareness of the risks, I, for myself and on behalf of my family, spouse, estate, heirs, executor, administrators, assigns, and personal representative, forever release and waive my right to sue Sonoma Media Investments, LLC and its owners, officers, directors, manager, officials, trustees, agents, employee, or other representatives in connection with exposure, infection and/or spread of COVID-19 related to my presence at any Activities. I understand that this waiver means I give up my right to bring any claims for personal injuries, death, disease or property losses, or any other loss, including but not limited to claims of negligence, and I give up any claim I may have to seek damages, whether known or unknown, foreseen or unforeseen.
